



#### **Message from the President**



#### May 2, 2001

It is my privilege to submit to the four founding sponsors of the Calgary Homeless Foundation, to our Patron and to the communityat-large, the third Annual Report of the Foundation.

The Chairs of the individual Committees of the Foundation report significant progress in building an organization that raises funds, promotes awareness and supports the community planning, review and funding processes to move project proposals to completion. I want to note a number of the highlights from the past twelve months.

#### Three Year Community Plan Building Community Strength

The Community Action Committee (CAC) of the Foundation served as the catalyst to bring the community together to prepare a three year plan to address homelessness in Calgary. I want to recognize the leadership of Co-Chairs Bonnie Laing and Alderman Bob Hawkesworth and the work of their committee on this achievement. The Plan is guiding the eight sectors and the funding agencies and foundations in their ongoing work.

In addition, a project application, review and ranking process was developed under the direction of CAC, by Drs. Hiebert and Cairns of the University of Calgary. The degree of consultation and cooperation achieved in this process is remarkable and is a positive indication that agencies are able to recognize and respond to the greater community need.

The Foundation has supported the development of community capacity by working directly with agencies on applications and on project implementation. This work was enhanced by the growing number of volunteers which now numbers over 150.

#### **Progress on Projects to Address Homelessness**

Significant progress has been achieved on some urgent Calgary projects to address homelessness. The Salvation Army Centre of Hope and the new Calgary Drop-In Centre are advancing quickly towards completion in the fall of 2001. The opening of these facilities will address the serious over-crowding in current emergency facilities and allow more effective delivery of programs to assist

residents in their efforts to return to self sufficiency. The Foundation is pleased to have provided funding to both projects and to have supported them in many non-monetary ways over the past three years. Together with the Mustard Seed Creative Centre, these projects represent a major step forward.

Some of the other priority projects supported by the Foundation include:

• Supported housing for persons living with mental illness. During the past year the Foundation partially funded the acquisition of a 50 unit bachelor apartment building by Horizon Housing. The Foundation also facilitated the establishment of a relationship between Horizon Housing and The Order of Good Cheer, which allowed the purchase of an 8-unit duplex for people living with mental health challenges.

• Supported post-addictive transitional housing. The Foundation partnered with two organizations; Oxford House Foundation and Simon House Foundation to purchase existing houses for this purpose. The substantial down payment provided by our Foundation allowed the agencies to fund mortgage and taxes more cost effectively than leasing third party owned houses.

• Native Addictions Services (NAS). NAS has acquired a site for a new facility and the Foundation continues to work closely with the organization to secure the substantial funding required to allow construction to proceed.

#### **Fundraising and Special Events**

The committed efforts of the Fundraising Committee under Honourary Chair, Mr. Jim Stanford, Chair Brian Olson and Vice-Chair Bill Kilbourne continues to attract a growing pool of fundraisers. Foundations such as the Calgary Foundation and the Kahanoff Foundation continue to strongly support our efforts. Numerous corporations have made multi-year commitments and the committee continues to attract a larger pool of fundraisers.

Two successful special events were held this year including the annual Premier's Roast that raised money for and awareness of the issue of homelessness. We are fortunate to have the support of the Premier and applaud his willingness to subject himself to this annual ritual. We launched a new relationship with the Calgary Home and Garden Show that promises to grow into a larger ongoing partnership.

In addition to the \$1.8 million provided by the Alberta and Federal Governments, the Foundation raised over \$850,000 in cash donations. This year, donations in-kind plus donations facilitated by the Foundation made directly to agencies or projects exceeded \$1.5 million.

#### **Aboriginal Community**

A broad-based membership has been attracted to the Aboriginal Standing Committee on Housing and Homelessness, and a focused business plan has been developed. The Committee is acting in multiple roles, including; as a forum for assessing projects for funding under the Urban Aboriginal Program of the Federal Government, providing encouragement and support for Aboriginal organizations and as an advocate for Aboriginal people who are in need of housing or supportive programs.

### **Message from the President**

#### Awareness

The Foundation has participated in the work of the Homeless Awareness Committee, which has brought together many agencies and community members to raise the public's knowledge of the issue. The Committee and community agencies, including our Foundation face a continuing challenge in raising the awareness, understanding and acceptance required to overcome the NIMBY (Not In My Back Yard) reaction to proposed projects.

#### Funders' Table

The creation of the Funders' Table is a major development that, taken with the evolving community review process, provides an efficient system to move priority projects to completion. Funders have found the exchange of information at the Table to be very useful, and agencies appreciate the ability to inform multiple potential funders through one process.

#### Affordable Housing

The shortage of affordable housing in Calgary is a serious and growing concern, and one that will receive the attention of the Calgary Homeless Foundation over the next few years. We will be making proposals to, and working with governments, as well as the

### **EXECUTIVE DIRECTOR'S REPORT**

During the past year, front-line agencies have made significant progress in responding to the problem of homelessness in Calgary. The Calgary Homeless Foundation is proud to have provided some of the funding and other support to help agencies implement much needed projects.

#### Community Involvement and Establishment of the Funders' Table

An important achievement over the year was the development of a community-based process to invite, review and prioritize applications for funding of capital projects and programs to address homelessness. The successful operation of the process required a great commitment of time and a selfless attitude from the representatives of community agencies. The development of the Funders' Table bringing together representatives of over 12 foundations, government departments, agencies, and the United Way was another important achievement. The decision-making process simplified and coordinated the involvement of many of the potential sources of funding. This level of collaboration in setting priorities and reaching funding decisions is unprecedented in Canada and other communities are very interested in our model.

#### Housing Registry and Foundation Website

The Registry provides information on low cost rental housing and services for homeless and at risk persons. It has received approval for funding under the Smart Cities project, allowing an expansion of the project. The United Way has also funded a one-year position to help community agencies develop volunteer programs to collect and input current information on low-cost private sector rental opportunities.

private and not-for-profit sectors to advance solutions to address the seriously inadequate supply of appropriate, affordable housing.

Finally I want to extend our thanks to our Sponsors: Premier Ralph Klein, Mayor Al Duerr, Calgary Chamber of Commerce Presidents Kevin Gregor and Barry Rempel, and United Way Chairman Brian MacNeill for their support. The problems of homelessness and the shortage of affordable housing have developed over many years, and are complicated and difficult to address. I am encouraged, however, by greater attention to the issue in our country, and the determination of a growing number of people to achieve solutions. Working together, we are making a difference.

We continue to benefit from an extraordinarily motivated and active group of volunteers on our Board of Directors and Committees. Volunteers from the private sector, the non-profit sector and governments provide the energy and direction for our efforts. Staff involvement is intended to support the work of volunteers and to maximize the impact of their contribution.

I want to particularly thank our volunteer Board and Committee members for applying their time, and expertise to the issue of homelessness. I also want to recognize the extraordinary effort and commitment of Foundation Staff.

Remarkable progress has been made over the past year. However, in many ways the problems of homelessness are increasing. We will need to accelerate our accomplishments over the next few years, but based on the unity of purpose that has developed amongst community agencies and funders, and the support we are receiving from governments and donors. I believe this is achievable.

## **Americana House Horizon Housing**

Horizon Housing is an organization that provides housing for individuals living with mental health concerns and other special needs. They work closely with Canadian Mental Health, Calhome Properties and the Accessible Housing Society to provide support services for the tenants. Americana House, located in the downtown area provides 50 bachelor sized units for use by individuals living with mental illness and those with other special needs.



# **Berkana House Elizabeth Fry**

Berkana House is a cooperative effort between the Elizabeth Fry Society of Calgary and the John Howard Society designed to provide transitional housing for women who have been in conflict with the law and are moving to integrate into society and re-establish themselves in the community. The CHF assisted in the acquisition of six units, two of which are two-bedroom suites to provide space for children to live with their mothers.



# John E. Robson House

The 2000 Civic United Way "Days of Caring" Campaign undertook to develop transitional housing for larger families. With strong leadership from the Calgary Police Service, the City of Calgary Employees provided hours of volunteer "sweat equity" to build and furnish 10 family units plus a resource centre. These units provide families with subsidized transitional shelter for up to two years.









# **Oxford House Foundation**

The Oxford House Foundation of Canada provides housing for persons recovering from alcoholism in a program of self-run, self-supported homes. The Calgary Homeless Foundation supported the purchase of three separate residences this year, providing housing for 15 individuals.

# **Safe Haven Foundation**

The CHF supported the Safe Haven Foundation's development of a residence which will provide homes for six young women aged 12 to 18. These young women have formerly been on the street or are at risk of being on the street, and are now committed to completing their education and improving their lives.

### AUDITOR'S REPORT



# **Simon House Society**

Simon House Society operates five houses providing safe, affordable transitional housing within the community for men completing the first stages of treatment for addictions. In response to their request, funds were granted to support the purchase of a large side-by-side duplex which will house eight men.

### HOUSING REGISTRY REPORT

The Housing Registry Network (HRN), provides a one-stop low cost rental housing internet resource, successfully entered its third year of operations. Positive feedback has been received from agencies and individuals who have accessed the Registry to find affordable and appropriate housing. The partners on the Housing Registry Network continually work to improve the system. One ongoing challenge has been to increase information sources by capturing a larger supply of potentially hidden low-cost rental

housing. Through funding provided by United Way of Calgary and Area, in the coming year, partners in the Network will receive additional resources to assist them with locating available rental housing in their respective communities.

As well, in April 2001, John Currie, President and C.E.O. of the Calgary Homeless Foundation executed a contract with Calgary Technology Inc. to incorporate the Housing Registry Network into the Calgary "Infoport<sup>TM</sup> Community Empower-ment Project

(ICEP)". The ICEP project is one of the twelve "Smart Communities" demonstration projects chosen for funding by Industry Canada.

The Smart Communities (http://smartcommunities.ic.gc.ca/) initiatives are pilot projects to test the degree to which the use of information technologies can improve the way our communities work together.

ICEP (http://www.calgarytechnologies.com/smartcommunities/index.html) is Alberta's initiative, and is improving the information service to and between agencies that serve at-risk people in Calgary. There are nine sub-projects that will improve aspects of service at

> many of the service points in the city and improve the overall knowledge of service across the whole network of service providers.

> The Housing Registry Network, using the expertise and resources provided by the Infoport project, will upgrade the Network's technology, add public access terminals, and expand the Network to include five more partners.

> We are proud that the CHF can work together with other agencies to provide accessible online resources.

### **NOTES TO FINANCIAL STATEMENTS**

March 31, 2001

#### PURPOSE OF THE FOUNDATION 1.

The Calgary Homeless Foundation was incorporated under the Alberta Societies Act on September 4, 1998. The Foundation is a not-for-profit organization and is exempt from income taxes under the Income Tax Act. The Foundations' stated objectives are to serve as a community partner in identifying the causes and solutions to homelessness; to develop plans, in conjunction with all aspects of the community, that will provide access to housing for the homeless in Calgary; to provide leadership and focus to address homelessness issues in Calgary and to raise such funds a may be necessary to achieve these objectives.

#### SIGNIFICANT ACCOUNTING POLICIES 2.

The financial statements have been prepared in accordance with generally accepted accounting principles, and reflect the follow ing policies.

#### Cash

Cash is comprised of deposits with financial institutions.

#### Capital assets

Purchased computer equipment is recorded at cost and is amortized using the declining balance method at 50% per year.

Certain office equipment and furniture has been donated to the Foundation by various organizations. The fair value of these items at the date of contribution is not readily determinable, therefore these donations are not recognized in these financial statements.

#### **Revenue recognition**

Contributions are recognized as revenue when received or receivable if the amount to be received can be reasonably estimated and collection is reasonably assured.

#### **Contributed services**

Volunteers have contributed a variety of services to assist the Foundation in carrying out its objectives. Due to the difficulty of determining their fair value, contributed services are not recognized in these financial statements.

The Aboriginal Standing Committee on Housing and Homelessness has enjoyed a highly successful year, achieving the goals of developing the plan, processes and partnerships necessary for the implementation of the Aboriginal component of the Community Action Plan. The primary focus was on the development of specific proposals and projects that could receive funding and support from the partners and collaterals of the Calgary Homeless Foundation.

#### **Budget/Finance/Audit**

The fiscal year ending March 31, 2001 was our best yet from a financial perspective. During this year the CHF raised over \$2,700,000. Over \$850,000 of these funds came from the Calgary Community through direct donations and special events. In addition, the Provincial Government contributed over \$1,000,000 and the Federal Government in excess of \$800,000. It is important to note the significant in-kind contribution of the City of Calgary, which has provided staff and property donations.

We were also effective at deploying these funds. CHF actual contributions to projects during the year exceeded \$1,900,000 and an additional \$530,000 was committed. A further \$1,275,000 in funds has been earmarked for potential project disbursement.

The past year has been a very exciting one for the CAC. Some major steps were put in place to address our three goals of:

- The creation of partnerships
- Identification of short and long term priorities
- Brokering resources and expertise

The Calgary Community Plan 2000, a report that forms the basis of the leveraging of funding from both the Federal and Provincial Government, was completed. Professors Hiebert and Cairns of the University of Calgary were contracted to monitor, facilitate and evaluate the process by which agencies and groups went through proposal development to access funding. As the homeless proposals required matching funds for the Federal and Provincial dollars, a Funders' Table was established to assist the agencies in a coordinated and efficient way to identify the possible available funding from the various funders. A task force led by George Coppus is developing a long-term planning strategy. They are working on formulating insights, plan-

ning tools and policy recommendation to more effectively address homelessness. A key part of the project is the development of an interactive computer simulation model that has been called "Homeopoly". This model is built using state-of-the-art systems dynamics tools and captures the systemic relationships between homelessness issues. The task force is also working with a team of students from MIT who have made Calgary homelessness a classroom project.
